## **RELEASE OF TRADEMARK SECURITY INTEREST**

**WHEREAS**, that certain Trademark Security Agreement, dated September 1, 2017 that was entered into by Grantee and Grantor was recorded with the United States Patent and Trademark Office on September 6, 2017 at Reel 6148 Frame 0031 (the "Trademark Security Agreement"; capitalized terms used herein but not otherwise defined herein shall have the meanings given to them in the Trademark Security Agreement).

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby (releases, without any representation, recourse or undertaking by Grantee, any and all liens on and security interests it has or may have in the Grantor's Trademark Collateral granted pursuant to the Collateral Agreement and the Trademark Security Agreement, including, without limitation, with respect to the Trademark Collateral listed on Schedule 1 hereto.
