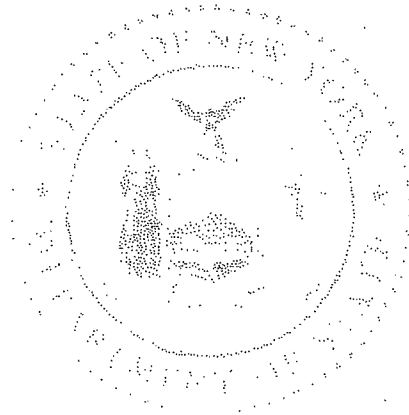

The Certificate of Incorporation is amended to change the corporate name. Paragraph FIRST of the certificate, which sets forth the name of the corporation, is amended to read:

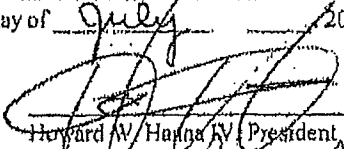
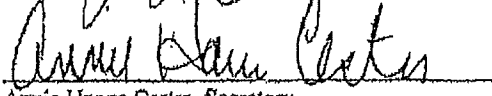
ARTICLE 1
