TERMINATION OF SECURITY AGREEMENT


THIS AGREEMENT, dated January 22, 2018, is among HANSER MUSIC GROUP INC. ("HMG"), Ohio corporation having an address at 3015 Kustom Drive, Hebron, KY 40108, KUSTOM MUSICAL AMPLIFICATION, INC. ("KUSTOM"), an Ohio corporation having an address at 3015 Kustom Drive, Hebron, KY 40108, and GURUZ MEDIA INC. ("DEBTOR") a Florida corporation having its principal business address at 26133 US 19 North, Clearwater, FL 33763.

A. Pursuant to a Security Agreement (the "Security Agreement"), dated January 29, 2016, and recorded in the USPTO in Reel 005735 at Frame 0949, DEBTOR granted a security interest in certain trademarks listed on Schedule A to HMG and KUSTOM as secured party.


