INTELLECTUAL PROPERTY ASSIGNMENT

This INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT ("**IP Assignment**"), dated as of November 8, 2017 ("**Effective Date**"), is made by Evergreen Enterprises of Virginia, LLC ("**Assignor**"), a Delaware Limited Liability Company, located at 5915 Midlothian Turnpike, Richmond, Virginia, in favor of Bambeco Lifestyle International LLC ("**Assignee**"), a Virginia Limited Liability Company, located at 5915 Midlothian Turnpike, Richmond, Virginia.

WHEREAS, Assignor was a party to an Asset Purchase Agreement dated October 26, 2017 ("**APA**") in which Assignor acquired certain Intellectual Property Assets ("**IP Assets**") on behalf of a newly formed affiliate business entity;

WHEREAS, Assignee, the legal entity for whom the IP Assets were acquired through the APA, was duly established under the laws of the State of Virginia on November 8, 2017; and

WHEREAS, Assignor and Assignee desire to formally transfer, convey and assign the IP Assets to Assignee and to use this instrument for the recording of IP Assets with domestic and foreign governmental authorities, including, but not limited to, the United States Patent and Trademark Office.

NOW, THEREFORE, in consideration of the sum of Ten Dollars (\$10.00) and for other valuable considerations, the receipt and sufficiency whereof are hereby acknowledged, Assignor does hereby sell, assign and transfer to Assignee, its successors, assigns, and legal representatives, Assignor's entire and exclusive right, title and interest to the following:

(a) the trademark registrations and applications set forth in Schedule 1 hereto, together with the goodwill connected with the use of and symbolized thereby and all issuances, extensions and renewals thereof (the "**Trademarks**"); provided that, with respect to the United States intent-to-use trademark applications set forth in Schedule 2 hereto, the transfer of such applications accompanies the transfer of Assignor's business, or portion of the business to which the trademark pertains, and that business is ongoing and existing;


(b) the patents and patent applications set forth in Schedule 2 hereto and all issuances, divisions, continuations, continuations-in-part, reissues, extensions, reexaminations and renewals thereof (the "**Patents**");
