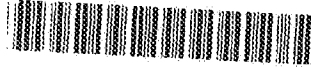

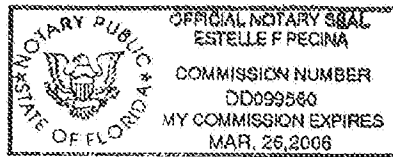

DECLARATION OF R. VICTOR GIORGINI


PURSUANT TO 37 C.F.R. § 503.06(e)
