**DECLARATION IN SUPPORT OF REQUEST FOR CORRECTION OF
MINOR CLERICAL ERROR IN RECORDED ASSIGNMENT DOCUMENT**

Pursuant to TMEP Section 503.06(a) and (b), U.C Coatings, LLC seeks to correct a minor error that appears in its name as set forth in the Trademark Assignment Cover Sheet and Trademark Assignment recorded on July 13, 2016, at Reel 005833, Frame 0714, for the trademarks SEAL-ONCE POLY, Registration No. 4,698,608, SEAL ENDS ONCE, Registration No. 4,488,468, THE WATER STOPS HERE, Registration No. 4,164,382, SEAL-ONCE, Registration No. 4,044,856, and SEAL ONCE, Registration No. 3,073,260. U.C Coatings, LLC was the Receiving Party / Assignee in the conveyance, but was incorrectly identified as "U-C Coatings LLC". The correct legal name of the Receiving Party / Assignee was and continues to be "U.C Coatings, LLC". U.C Coatings, LLC is the current owner of these trademark registrations.

In support of the requested correction, U.C Coatings, LLC further states:

1. The undersigned has firsthand knowledge of the facts contained herein.
2. No legal entity existed at the time of the Assignment (or is currently known) as U-C Coatings LLC.
3. The correct legal name of the Receiving Party / Assignee was and is U.C Coatings, LLC.
4. The Receiving Party / Assignee was incorrectly identified in the Trademark Assignment Cover Sheet and in the Trademark Assignment due to minor clerical error. A hyphen was incorrectly included between the "U" and "C", which should have been a period, and a comma was omitted between "Coatings" and "LLC".
5. U.C Coatings, LLC hereby requests that the Receiving Party / Assignee be corrected to U.C Coatings, LLC.
6. U.C Coatings, LLC is a limited liability company organized under the laws of the State of Delaware. Its business address is 2250 Fillmore Avenue, Buffalo, New York 14214.

This Declaration is submitted on behalf of U.C Coatings, LLC by an officer authorized to act on its behalf.
