TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement ("Agreement") is effective as of **December 11, 2017** (the "Effective Date") by and between **Noblis, Inc.**, a Delaware nonprofit corporation, with offices at 2002 Edmund Halley Drive, Reston, Virginia 20191 (the "Assignor") and **Med-Turn, Inc.**, a Texas corporation, with offices at 635 Vine St., Winston-Salem, North Carolina 27101 (the "Assignee"). Assignor and Assignee may collectively be referred to as the "Parties."

WHEREAS, Assignor owns the marks that are listed on the attached Schedule 1, including any applications and registrations thereof (the "Marks").

WHEREAS, the Parties entered into that certain Asset Purchase Agreement, dated as of **December 11, 2017** (the "Asset Purchase Agreement").

WHEREAS, pursuant to the transactions contemplated by the Asset Purchase Agreement, the Parties mutually desire that Assignee acquire Assignor's entire right, title and interest in and to the Marks.

NOW THEREFORE, for good and valuable consideration paid by Assignee, receipt of which is hereby acknowledged, the Parties agree as follows:

1. Assignor on behalf of itself and its predecessors and successors in interest, hereby assigns and transfers to Assignee, its successors and assigns, all of Assignor's right, title and interest in and to: (a) the Marks, (b) all goodwill embodied in and relating to the Marks, (c) the right to apply for trademarks, registrations and renewals thereof, together with all rights of action and claims for damages and benefits arising because of past infringement of said trademarks, and the right to sue and collect damages and/or profits for past infringements of the Marks, together with assets of the business, which business is ongoing and existing.


2. Assignor hereby acknowledges that it retains no right to use the Marks and agrees not to challenge or to assist others to challenge the validity, or Assignee's ownership, of the Marks. Assignor covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into by Assignor that would conflict with this Agreement.
