## RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS dated January 2, 2018 by BMO Harris Bank N.A., a national association ("*BMO Harris*"), with its mailing address at 111 West Monroe Street, Chicago, IL 60603, acting as administrative agent hereunder for itself and the other Credit Parties (BMO Harris acting as such administrative agent being hereinafter referred to as the "*Agent*");

### WITNESSETH:

WHEREAS, CLEARENT, LLC, a Missouri limited liability company (the "*Debtor*") with its principal place of business and mailing address at 222 S.
