**TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT**

**THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this "Termination"), is dated as of January 26, 2018, and made by **TRIANGLE CAPITAL CORPORATION**, in its capacity as agent (in such capacity, "Grantee") in favor of the Grantors listed on the signature pages to the Security Agreement (as defined below) (collectively, jointly and severally, "Grantors" and each individually "Grantor").

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of December 18, 2015, made by the Grantors in favor of Grantee (as amended to date, the "Security Agreement"), a security interest was granted by the Grantors to Grantee in certain collateral, including the Trademarks (as hereinafter defined);

WHEREAS, the Security Agreement was recorded in the United States Patent and Trademark Office on December 30, 2015, at Reel 5698 and Frame 0851; and

WHEREAS, Grantee now desires to terminate and release the Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:

1. Definitions. The term "Trademarks," as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the Trademarks listed on Schedule A hereto.

2. Release of Security Interest. Grantee hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Trademarks and all other Trademark Collateral (as defined in the Security Agreement) and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Trademarks and all other Trademark Collateral.
