**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARK RIGHTS**

**THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS**, dated as of January 26, 2018, is made by Healthcare Financial Solutions, LLC (as successor in interest to General Electric Capital Corporation), as administrative agent ("Lender"), under that certain Trademark Security Agreement, dated as of July 25, 2016, by each of the entities listed on the signature pages thereof (each a "Grantor" and, collectively, the "Grantors"), in favor of the Lender (as amended, supplemented or modified and in effect from time to time, the "Trademark Security Agreement").

**WHEREAS**, pursuant to the Trademark Security Agreement, the Grantors granted a security interest to the Lender in certain intellectual property collateral including the Trademarks set forth on Schedule I thereto (the "Trademark Collateral"); and

**WHEREAS**, an executed copy of the Trademark Security Agreement was recorded with the Trademark Assignment Recordation Branch of the United States Patent and Trademark Office on July 26, 2016 at Reel 5840, Frame 0127; and

**WHEREAS**, the Lender has agreed to terminate and release its security interest in all of such Trademarks, including, without limitation, the Trademarks identified on Schedule A attached hereto, being the same Trademarks set forth on Schedule I to the Trademark Security Agreement.

**NOW, THEREFORE**, for good and valuable consideration, the receipt of which is hereby acknowledged, the Lender does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Trademark Security Agreement in the Trademark Collateral, (b) release its security interest in the Trademark Collateral, and (c) discharge any and all rights, title and interest it has in and the security interest granted to Lender in the Trademark Collateral.
