GRANT OF SECURITY INTEREST
IN UNITED STATES TRADEMARKS

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, in order to induce the Lenders (as defined below) to make extensions of credit and other financial accommodations to, among others, KRISER'S FEEDING PETS FOR LIFE, LLC, a Delaware limited liability company with its chief executive office at 1906 Olympic Boulevard, Santa Monica, CA 90404, and ESPECIALLY FOR PETS, LLC, a Delaware limited liability company with its chief executive office at 1185 Chestnut Street, Newton, MA 02464 (each a "Grantor" and, together, the "Grantors") pursuant to (i) the Credit Agreement, dated as of December 22, 2017 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), between Independent Pet Partners Intermediate Holdings, LLC, a Delaware limited liability company ("IPP Intermediate"), as the borrower representative and, together with the Grantors and Pet Life, LLC, a Delaware limited liability company, as borrowers, the Guarantors (as defined therein), the Lenders (as defined therein) from time to time party thereto and each lender from time to time party thereto (collectively, the "Lenders" and each, individually, a "Lender"), and CIT BANK, N.A., with offices at 11 West 42nd Street, 13th Floor, New York, NY 10036, as administrative agent and collateral agent for the Lenders (in such capacity, the "Agent"), and (ii) the Security Agreement, dated as of December 22, 2017, executed and delivered by, among others, each Grantor in favor of the Agent in connection with the Credit Agreement (as amended, restated supplemented or otherwise modified from time to time, the "Security Agreement") under which each Grantor pledged and granted to CIT BANK, N.A., as Agent, a continuing security interest in all of each Grantor's Intellectual Property. Each Grantor hereby pledges and grants a continuing security in, to and under all of each Grantor's right, title and interest in each United States Trademark (including, without limitation, those items set forth on Schedule A attached

hereto) for the benefit of the Credit Parties to secure payment, performance and observance of the Obligations.

Unless otherwise defined herein or the context otherwise requires, terms used herein have the meanings provided or provided by reference in the Credit Agreement and the Security Agreement (as applicable). This grant of security interest in United States Trademarks (this "Grant") has been executed and delivered by the Grantors for the purpose of recording the grant of security interest herein with the United States Patent and Trademark Office. The Grantors authorize and request that the Commissioner for Trademarks record this Grant. The security interest granted hereby has been granted to the Agent for the benefit of the Credit Parties in connection with the Security Agreement and is expressly subject to the terms and conditions thereof. The rights and remedies of the Agent with respect to the security interest granted herein are as set forth in the Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Grant are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.

This Grant may be executed in any number of counterparts and by different parties hereto in separate counterparts, each of which shall be deemed to be an original, but all of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page to this Grant by telecopier, facsimile or other electronic means shall be effective as delivery of a manually executed counterpart of this Grant.
