## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Release"), effective as of this 30th day of January, 2018, is made by **SUNTRUST BANK**, a Georgia bank, with an address at 211 Perimeter Center Parkway, Suite 100, Atlanta, Georgia 30346, as administrative agent (in such capacity, together with its successors and permitted assigns, the "Administrative Agent") for the Lenders in favor of **JH GLOBAL IP LIMITED**, a British Virgin Islands business company ("Grantor"), as follows:

### W I T N E S S E T H

WHEREAS, the Grantor and the Administrative Agent are party to that certain Guaranty and Security Agreement, dated as of March 23, 2015 (as amended, supplemented or otherwise modified from time to time, the "Security Agreement"), pursuant to which the Grantor granted to the Administrative Agent, among other Collateral as defined and set forth in the Security Agreement, a security interest in and to all Grantor's right, title and interest in all trademarks and trademark licenses, including as set forth on Schedule 1 attached hereto (collectively, the "Trademarks"), including all goodwill of the business connected with the use of, and symbolized by, each Trademark;

WHEREAS, in furtherance of the Security Agreement, the Grantor executed an Intellectual Property Security Agreement, dated April 20, 2017 (the "Trademark Security Agreement"), which was duly recorded on April 20, 2017, at Reel/Frame 6038/0848 in the United States Patent and Trademark Office;

WHEREAS, the Administrative Agent wishes to release and restore all right, title and interest in and to the Trademarks to the Grantor and to dissolve those liens and encumbrances created by the Trademark Security Agreement and the Security Agreement in respect of the Trademarks.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Administrative Agent hereby grants, assigns, transfers and conveys, without recourse or warranty, to the Grantor all of its rights, title and interest in the Trademarks, including any goodwill associated therewith, and terminates, releases, discharges, quitclaims and relinquishes unto the Grantor any and all security interests and liens it has against the Trademarks.

The Administrative Agent hereby agrees, at Grantor's sole cost and expense, to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the intents and purposes of this Release.
