## **RELEASE OF SECURITY INTEREST IN SPECIFIED U.S. TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN SPECIFIED U.S. TRADEMARKS (this "Release") is entered into as of January 30, 2018 by JPMorgan Chase Bank, N.A., a National Banking Association located at 1300 East Ninth St., Floor 13, Cleveland, Ohio, 44114, in its capacity as administrative collateral agent for the Lenders party to the Second Amended and Restated Credit Agreement referred to below (the "Assignor"), in favor of Cott Beverages Inc., a Georgia corporation with offices located at 5519 West Idlewild Avenue, Tampa, Florida 33634-8016 ("Cott Beverages") and Cliffstar LLC, a Delaware limited liability company with offices located at 5519 West Idlewild Avenue, Tampa, Florida 33634-8016 ("Cliffstar") (each, an "Assignee," and collectively, the "Assignees"). Unless otherwise defined herein, capitalized terms defined in the Amended and Restated Credit Agreement, Security Agreement, Reaffirmation Agreement or any of the Trademark Security Agreements and used herein have the meaning given to them in the Amended and Restated Credit Agreement, Security Agreement, Reaffirmation Agreement or such Trademark Security Agreement, as applicable.

**WHEREAS**, reference is made to that certain (i) Amended and Restated Credit Agreement, dated as of August 3, 2016 (as amended, restated, supplemented or modified from time to time, the "Amended and Restated Credit Agreement"), by and among Cott Corporation Corporation Cott, a corporation organized under the laws of Canada ("Cott Corporation"), Cott Beverages, Cliffstar, Cott Beverages Limited, a company organized under the laws of England and Wales, as Borrowers and DS Services of America, Inc., a Delaware corporation ("DS Services"), the other Loan Parties party thereto, the Lenders party thereto, JPMorgan Chase Bank, N.A., London Branch, as UK Security Trustee, JPMorgan Chase Bank, N.A., as Administrative Agent and Administrative Collateral Agent, and each of the other parties party thereto; (ii) U.S. Pledge and Security Agreement, dated as of August 17, 2010 (as it may be amended, restated, supplemented or modified from time to time, the "Security Agreement") by and among the Assignor and the Assignees and the other grantors named therein; (iii) Reaffirmation Agreement; Grant and Amendment No. 3 to U.S. Security Agreement, dated as of August 3, 2016 (as it may be amended, restated, supplemented or modified from time to time, the "Reaffirmation Agreement"), between the Assignor and the Assignees and the other parties thereto; (iv) U.S. Trademark Security Agreement dated as of August 17, 2010 (the "Original Trademark Security Agreement"), between the Assignor and Assignees; (v) Trademark Security Agreement dated as of August 17, 2010 ("2010 Cott Trademark Security Agreement") between the Assignor and Cott Corporation; (vi) Supplemental U.S. Trademark Security Agreement dated as of April 28, 2010 ("First Original Supplemental Trademark Security Agreement") between the Assignor and Cott Beverages; (vii) U.S. Trademark Security Agreement (Supplemental) dated as of May 9, 2012 (the "Second Original Supplemental Trademark Security Agreement") between the Assignor and the Assignees, (viii) U.S. Trademark Security Agreement (Supplemental), dated as of August 31, 2016 (the "Supplemental Trademark Security Agreement") between the Assignor and the Assignees and DS Services; and (ix) U.S. Trademark Security Agreement (Reaffirmation Grant), dated as of August 31, 2016 ("Reaffirmation Trademark Security Agreement" and collectively with the Supplemental Trademark Security Agreement, the Original Trademark Security Agreement, the 2010 Cott Trademark Security Agreement, the First Original Supplemental Trademark Security Agreement and the Second Original Supplemental Trademark Security Agreement, the "Trademark Security Agreements") between the Assignor and Assignees;

**WHEREAS**, pursuant to the terms and conditions of the Security Agreement, the Reaffirmation Agreement and the Trademark Security Agreements, in furtherance of the reaffirmations set forth in the Reaffirmation Agreement and Section 2 of the Reaffirmation Trademark Security Agreement and the Supplemental Trademark Security Agreement, each Assignee pledged, assigned and granted to the Assignor, on behalf of and for the ratable benefit of the Secured Parties, a security interest in all of such Assignee's right, title and interest in, to and under the following personal property and other assets, in each case, whether then owned by or owing to, or thereafter acquired by or arising in favor of such Assignee (including under any trade name or derivations thereof), and whether owned or consigned by or to, or leased from or to, such Assignee, and regardless of where located (collectively, the "Trademark Collateral"), to secure the prompt and complete payment and performance of the Secured Obligations:

- a) all trademarks (including service marks), trade names, trade dress and trade styles, internet domain names and other source identifiers, and the registrations and applications for registration thereof including, but not limited to, the U.S. registered trademarks and service marks and the U.S. trademarks and service marks applications set forth on Schedule I thereto and the goodwill of the business symbolized by the foregoing;
- b) all licenses of the foregoing, whether as licensee or licensor;
- c) all renewals of the foregoing;
- d) all income, royalties, damages and payments now or hereafter due or payable with respect thereto, including, without limitation, damages, claims and payments for past and future infringements thereof;
- e) the right to sue for past, present and future infringements of the foregoing;
- f) all rights corresponding to any of the foregoing throughout the world; and
- g) all accessions to, substitutions for and replacements, proceeds (including Stock Rights), insurance proceeds and products of the foregoing, together with all books and records, customer lists, credit files, computer files, programs, printouts and other computer materials and records related thereto and any General Intangibles at any time evidencing or relating to any of the foregoing.

**WHEREAS**, (i) the Original Trademark Security Agreement was recorded with the United States Patent and Trademark Office ("USPTO") on August 31, 2010 at Reel/Frame No. 4270/0206; (ii) the 2010 Cott Trademark Security Agreement was recorded with the USPTO on August 20, 2010 at Reel/Frame No. 4264/0738; (iii) the First Original Supplemental Trademark Security Agreement was recorded with the USPTO on May 3, 2010 at Reel/Frame No. 4197/0395; (iv) the Second Original Supplemental Trademark Security Agreement was recorded with the USPTO on May 11, 2012 at Reel/Frame No. 4778/0024; (v) the Supplemental Trademark Security Agreement was recorded with the USPTO on September 1, 2016 at

Reel/Frame No. 5868/0589; and (vi) the Reaffirmation Trademark Security Agreement was recorded with the USPTO on September 1, 2016 at Reel/Frame No. 5869/0075;

**WHEREAS**, as further set forth in that certain Second Amendment and Restatement Agreement, dated as of the date hereof (the "Second Amendment and Restatement Agreement"), the Assignees constitute "Released Entities," and as a result, solely to the extent actually sold pursuant to the Refresco Transaction, the Assignor has agreed to terminate and release its security interest solely with respect to the U.S. registered trademarks and service marks and the U.S. trademark and service mark applications set forth on Schedule I hereto (the "Specified Trademarks") and Specified Trademark Collateral (as defined below) related thereto;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Assignor hereby terminates, releases and discharges fully, without representation, warranty or recourse, its security interest in all of each Assignee's right, title and interest in, to and under the following Collateral (the "Specified Trademark Collateral"): (i) the Specified Trademarks, (ii) all licenses of the foregoing, whether as licensee or licensor; (iii) all renewals of the foregoing; (iv) all income, royalties, damages and payments now or hereafter due or payable with respect thereto, including, without limitation, damages, claims and payments for past and future infringements thereof; (v) the right to sue for past, present and future infringements of the foregoing; (vi) all rights corresponding to any of the foregoing throughout the world; and (vii) all accessions to, substitutions for and replacements, proceeds (including Stock Rights), insurance proceeds and products of the foregoing, together with all books and records, customer lists, credit files, computer files, programs, printouts and other computer materials and records related thereto and any General Intangibles at any time evidencing or relating to any of the foregoing.


The Assignor hereby authorizes the Assignees or the Assignees' designee to record this Release with the USPTO.

For the avoidance of any doubt, this Release is strictly limited solely and only to the Specified Trademark Collateral and to no other Collateral. The Assignor continues to maintain, without interruption or impairment, its security interest in all Trademark Collateral other than the Specified Trademark Collateral. The provisions of the Security Agreement, Reaffirmation Agreement, and Trademark Security Agreements shall, except as modified by this Release, continue in full force and effect.

**THIS RELEASE SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, AND ANY DISPUTE BETWEEN ANY ASSIGNEE AND THE ASSIGNOR ARISING OUT OF, CONNECTED WITH, RELATED TO, OR INCIDENTAL TO THE RELATIONSHIP ESTABLISHED BETWEEN THEM IN CONNECTION WITH, THIS RELEASE, AND WHETHER ARISING IN CONTRACT, TORT, EQUITY, OR OTHERWISE, SHALL BE RESOLVED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK (INCLUDING 5-1401 OF THE GENERAL OBLIGATION LAW OF THE STATE OF NEW YORK BUT OTHERWISE WITHOUT REGARD TO THE CONFLICTS OF LAWS PROVISIONS).**
