**RELEASE AND REASSIGNMENT OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY**

January 30, 2018

This Release and Reassignment of Security Interest in Intellectual Property (“*Release*”), effective as of the date first above written (the “*Effective Date*”), is entered into by and between EAST WEST BANK, a California corporation (“*Bank*”) having a place of business at 9300 Flair Drive, 6th Floor, El Monte, California 91371 and COMMAND PACKAGING, LLC, a California limited liability company (“Grantor”) formerly known as GRAND PACKAGING, INC., a California corporation (“*Grand Packaging*”) having its principal place of business at 3840 East 26th Street, Vernon, California 90058.

WHEREAS, Grand Packaging granted a certain security interest in favor of Bank, effective as of April 21, 2017, which granted East West Bank a security interest in Intellectual Property Collateral (as defined in that certain Commercial Security Agreement, dated as of April 21, 2017, by and between Grand Packaging and Bank (the “*Commercial Security Agreement*”), including but not limited to the trademark registrations set forth on Schedule A, hereto, together in each case with the goodwill of the business connected with the use of, and symbolized by, each such trademark, service mark, trade name, trade dress, Internet domain name or other indicia of trade origin of any such mark (the “*Trademarks*”);

WHEREAS, on May 1, 2017, Bank recorded with the United States Patent and Trademark Office (the “*USPTO*”), at Reel 006044, Frame 0776, a notice of Bank’s security interest in the Trademarks; and

WHEREAS, Grantor has satisfied all obligations relating to the security interest granted to Bank; and

WHEREAS, the parties desire to confirm the release and reassignment of Bank’s security interest to Grantor.

NOW THEREFORE, in consideration of the foregoing recitals (which are incorporated into and made a part of this Release), the covenants set forth below and for other good and valuable consideration, the sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

1. Release of Security Interest. Effective as of the Effective Date, Bank hereby forever releases, terminates and extinguishes its security interest in and to the Intellectual Property Collateral and releases any and all such security interest to Grantor, including but not limited to the Trademarks, and further disclaims any and all ownership interest in and to the Trademarks and the Intellectual Property Collateral in favor of Grantor, together in each case with the goodwill of the business connected with the use of, and symbolized by, each such Trademark.

2. Recordation of Release. Bank understands and agrees that this Release may be recorded by or for the Grantor with the USPTO.


3. Further Assurances. Bank will take such further reasonable action as may be requested by Grantor to confirm the release of Bank's security interest and to acknowledge Grantor's ownership of all right, title and interest in and to the Intellectual Property Collateral, including but not limited to the Trademarks, together in each case with the goodwill of the business connected with the use of, ad symbolized by, each such Trademark, at the sole cost and expense of Grantor.

4. Capitalized Terms. Capitalized terms used herein and not otherwise defined shall have the meanings ascribed thereto in the Commercial Security Agreement, as applicable.
