TRADEMARK ASSIGNMENT

This Trademark Assignment is dated as of 15 January 2018, and is by and between Chr. Hansen, Inc., a Wisconsin corporation having an address of 9015 W. Maple Street, Milwaukee, Wisconsin 53214, United States of America (the "*Assignor*"), and Chr. Hansen A/S, an Aktieselskab (public limited company) of Denmark having an address of Bøge Alle 10-12 Hørsholm Denmark 2970 (the "*Assignee*").

WHEREAS, Assignor is the owner of the mark M74 and similar variations thereof (the "*Mark*") as a result of the merger of Medipharm Investments, Ltd. d/b/a Medipharm USA into Chr. Hansen, Inc.; and

WHEREAS, Assignee desires to acquire from Assignor, and Assignor wishes to transfer to Assignee all right, title and interest in and to the Mark.

NOW, THEREFORE, for \$10.00 (ten dollars) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby assigns to Assignee all right, title and interest in and to the Mark together with the goodwill of the business symbolized by the Mark, U.S. Trademark Registration No. 3,378,484 for the Mark, any renewals thereof, any and all other applications and registrations of the Mark, and any renewals thereof, and all common law rights associated with the Mark; the right to sue or otherwise recover for any and all past, present and future infringement or dilution of the Mark; all income, royalties, damages, and other payments now and hereafter due and payable with respect to the Mark; and all other rights, whether statutory or common law, corresponding thereto and all other rights of any kind whatsoever accruing thereunder.

Assignor further agrees to execute all documents, papers, forms, and authorizations and to take any and all other actions that may be necessary for securing, completing, or vesting in Assignee full right, title and interest in and to the Mark.

Assignor hereby requests the United States Commissioner of Trademarks, and the corresponding entities or agencies in any applicable foreign countries, to record Assignee as the assignee and owner of the Mark.






