TRADEMARK ASSIGNMENT

WHEREAS, the Seller and CCA Acquisition, LLC, a Delaware limited liability company (the "Purchaser") are parties to that certain Purchase and Sale Agreement, dated November 13, 2017 (the "Purchase Agreement"; capitalized terms used but not defined herein shall have the meanings assigned to them in the Purchase Agreement), pursuant to which the Seller will sell, transfer, assign, convey and deliver to the Purchaser all of the issued and outstanding shares of common stock of Assignor;

WHEREAS, prior to the Closing, the Seller has agreed to undertake the Pre-Closing Restructuring, pursuant to which, among other things, the Seller (or its applicable Affiliate) shall assign to Assignor (or the applicable Purchased Subsidiary) all of the Seller's (or such Affiliate's) right, title and interest in any and all Company Intellectual Property and Assignor (or the applicable Purchased Subsidiary) shall assign to the Seller (or its applicable Affiliate) all of Assignor's or such Purchased Subsidiary's right, title and interest in any and all Intellectual Property not Related to the Company Business;

WHEREAS, Assignor now wishes to assign the Marks to Assignee, and Assignee is desirous of acquiring the Marks from Assignor, together with the goodwill of the business symbolized thereby;

WHEREAS, the execution and delivery of this Assignment is a condition to Closing under the Purchase Agreement.

NOW, THEREFORE, in consideration of the premises set forth above and in the Purchase Agreement and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

Assignor does hereby sell, assign, convey and transfer unto Assignee and its successors, assigns and legal representatives, Assignor's entire right, title and interest in and throughout the world in and to the Marks (including any common law rights that may exist and are associated therewith), together with the goodwill of the business symbolized thereby and appurtenant thereto, the same to be held and enjoyed by Assignee, its successors, permitted assigns or legal representatives, together with income, royalties, damages or payments due on or after the date hereof, including, without limitation, all claims for damages or payments by reason of infringement or unauthorized use of the Marks, along with the right to sue for past infringements and collect same for Assignee's sole use and enjoyment.

Assignor does hereby authorize the Director of the United States Patent & Trademark Office, and the empowered official of any country or countries foreign to the United States whose duty it is to record trademark registrations, applications and title thereto, to record the Marks and title thereto as the
