2. Assignor shall, from time to time and as necessary, execute and deliver to Assignee all agreements and other documents reasonably necessary to give effect to this Assignment.

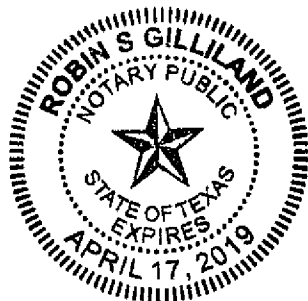
