TRADEMARK AND INTELLECTUAL PROPERTY ASSIGNMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, ASSIGNOR hereby irrevocably assigns and transfers to ASSIGNEE, its successors and assigns, in perpetuity all right, title, and interest in and to all trademarks, service marks, copyrights and other Intellectual Property owned by ASSIGNOR, in the United States and in any other country, together with all goodwill of the business symbolized by and associated with such Intellectual Property, and all rights of ASSIGNOR associated therewith, including the right to sue for and collect damages by reason of past infringements of the Intellectual Property. The term "INTELLECTUAL PROPERTY" refers to and includes all Assignor's trademarks, trade names, titles, tag lines and service marks (collectively, "MARKS"), copyrights, domain names, patents, inventions (whether now known or hereinafter invented), trade secrets, licensed rights, and know-how throughout the world, whether registered or unregistered, and all registrations and applications therefor, including, but not limited, those set forth in Attachment A to this Trademark and Intellectual Property Assignment Agreement (the "Assignment"), together with the goodwill of the business symbolized by the Marks. The rights assigned include, but are not limited to, any causes of action relating to said Intellectual Property and claims for damages, profits and costs, both in equity and law, for any infringement or infringements of said Intellectual Property accruing or occurring on, before or after the date of this Assignment. ASSIGNOR further assigns to ASSIGNEE the right to claim priority and any other rights deriving from the Intellectual Property by virtue of international convention, treaty, or otherwise. The Intellectual Property is to be held and enjoyed by ASSIGNEE for its use and benefit and by its successors and assigns for their use and benefit as fully and entirely as the same would have been held and enjoyed by ASSIGNOR had this agreement, transfer and sale not been made.

Assignor further agrees to execute such other documents and take other actions as Assignee or its representatives may reasonably request, including provision of passwords and log-in information, as necessary to effectuate the purpose of this Assignment, without further consideration. This agreement is binding on the parties, their principals, owners, employees, representatives, successors, heirs and assigns. This Assignment and any dispute arising under

it shall be governed by and construed in accordance with the laws of the State of Delaware without regard to conflict of law principles.

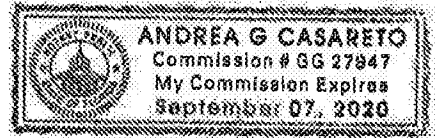

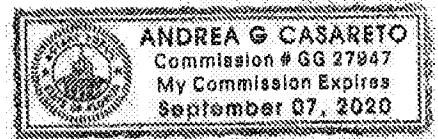


