**RELEASE OF SECURITY INTEREST IN  
INTELLECTUAL PROPERTY**

(ii) (a) Grant of Patent Security Interest, dated as of September 30, 2013 (the "Closing Date PSA") and recorded with the USPTO on October 11, 2013 at Reel/Frame Nos. 31396/0012 and 31396/0189, (b) IP Supplement to Grant of Patent Security Interest, dated as of February 25, 2014 (the "Patent Supplement") and recorded with the USPTO on February 25, 2014 at Reel/Frame Nos. 32333/0068, 32333/0056, and 32333/0318 (c) Grant of Patent Security Interest, dated as of February 25, 2015 (the "Elkhart PSA") and recorded with the USPTO on February 25, 2015 at Reel/Frame No. 35091/0017, (d) IP Supplement, dated as of June 30, 2015 (the "Elkhart Supplement") and recorded with the USPTO on July 2, 2015 at Reel/Frame No. 36051/0202, (e) Grant of Patent Security Interest, dated as of June 17, 2016 (the "RVS PSA") and recorded with the USPTO on June 17, 2016 at Reel/Frame No. 39071/0147, and (f) Grant of Patent Security Interest, dated as of January 11, 2017 (the "Randall PSA" and together with the Closing Date PSA, the Patent Supplement, the Elkhart PSA, the Elkhart Supplement, and the RVS PSA, collectively, the "Patent Security Agreements") and recorded with the USPTO on January 12, 2017 at Reel/Frame No. 41345/0973; and

(iii) (a) Grant of Copyright Security Interest, dated as of September 30, 2013 (the "Closing Date CSA") and recorded with the U.S. Copyright Office ("USCO") on October 11, 2013 at V3632 D694 and (b) IP Supplement to Grant of Copyright Security Interest, dated as of February 25, 2014 (the "Copyright Supplement" and together with the Closing Date CSA, the "Copyright Security Agreements") and recorded with the USCO on February 27, 2014 at V9907 D610,

pursuant to which the Grantors granted to the Secured Party a security interest in its Trademark Collateral (as defined in the Trademark Security Agreements), Patent Collateral (as defined in the Patent Security Agreements), and Copyright Collateral (as defined in the Copyright Security Agreements);

WHEREAS, as of the date hereof, all of the obligations secured by the security interest granted under the Trademark Security Agreements, the Patent Security Agreements, and the Copyright Security Agreements have been paid, performed, satisfied and discharged in full and, in connection therewith, the Grantors have requested that the Secured Party release its security interest in all of its right, title, and interest in and to the Trademark Collateral, Patent Collateral, and Copyright Collateral.


