TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Termination"), is dated as of January 31, 2018, and made by **PNC BANK, CANADA BRANCH**, in its capacity as Agent under the below-defined Security Agreement, having an office at 130 King Street West, Suite #2140, Toronto, Ontario M5X 1E4 ("Grantee") to DEALER-FX GROUP INC., a corporation incorporated under the laws of the Province of British Columbia ("Grantor"), with its chief executive office at 80 Tiverton Court, Markham, ON L3R 0G4.

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of January 11, 2017, made by Grantor in favor of Grantee (the "Security Agreement"), a security interest was granted by the Grantor to Grantee in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on January 19, 2017, at Reel 5971 and Frame 0254; and

WHEREAS, Grantee now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:


1. Definitions. The term "Trademark Collateral," as used herein, shall have the meaning set forth in the Security Agreement and includes, but is not limited to, all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the trademarks listed on Schedule A hereto.

2. Release of Security Interest. Grantee hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Trademark Collateral and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Trademark Collateral.
