Nothing contained in this Trademark Assignment shall be deemed to supersede any of the representations, warranties, covenants or other agreements contained in the Asset Purchase Agreement or otherwise expand any of the rights or remedies of the Assignee with respect to the transactions contemplated thereby. To the extent any of the provisions in this Trademark Assignment are inconsistent with the Asset Purchase Agreement, the Asset Purchase Agreement shall control.


This Trademark Assignment is binding on the Assignor and its successors and assigns, and inures to the benefit of the Assignee and its successors and assigns.
