Assignor hereby assigns to Assignee, as a successor-in-interest to Assignor’s business, Assignor’s entire right, title, and interest in and to the Marks and their respective registrations, together with any and all of the goodwill of the business symbolized by and associated with the Marks, and all income, royalties, fees, damages, and payments now or hereafter due or payable with respect thereto, and all rights of actions, powers, and benefit to the Marks, due or accrued, and including the right to sue for and recover in the Assignee’s own name and that of its successors and assigns and other legal representatives all remedies of every nature, including without limitation rights to injunctive relief, damages, profits, royalties, costs, and attorney fees, arising out of any infringement of the Marks, or injury to the related goodwill, occurring prior to or after the date of this Assignment.

Assignor agrees that, at Assignee’s sole expense, Assignor will take all lawful action reasonably deemed necessary by Assignee for perfecting, recording, or maintaining the title of Assignee in and to the Marks.
