RELEASE OF SECURITY INTEREST IN TRADEMARKS (SECOND LIEN)

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, subject to the terms and conditions of the Payoff Letter, Agent hereby releases its continuing security interest in, and lien upon, all of the Company's right, title and interest in, to and under the Registered Trademarks, including the trademarks listed on Schedule A attached hereto and made a part hereof.
