WHEREAS, olloclip or Premier is the owner of those certain trademark applications and registrations set forth in the attached Schedule A (the “**Trademarks**”); and

WHEREAS, this Assignment is being executed and delivered in furtherance of that certain Forbearance and Consensual Foreclosure Agreement dated as of December 5, 2017 and the foreclosure sale of December 15, 2017 contemplated thereby, and is not intended to in any way supersede, modify, replace, amend, change, rescind, waive, exceed, expand, enlarge, limit or affect any of the provisions (including the representations, warranties, covenants, agreements and conditions), transactions, transfers, obligations, duties, rights, interests or remedies set forth in or imposed thereby.

NOW, THEREFORE, for the consideration of USD \$10.00 and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Assignment of Rights. Effective upon the Effective Date, Assignors hereby distribute, transfer, assign, and otherwise convey to Assignee, its successors and assigns, all of Assignors’ right, title, and interest in and to the Trademarks as they exist anywhere in the world and as may be created or acquired at any date in the future, along with the goodwill of the business symbolized by or associated with the Trademarks, all applications and registrations for the Trademarks, and any and all priority rights or priority claims of International Convention rights, along with all rights to proceeds of the foregoing, including without limitation, income, royalties, damages, profits and payments now or hereafter due or payable with respect thereto, and any and all rights of action of Assignors, and the right to take proceedings and to seek and recover damages and all other available remedies, against third parties for past, present, or future infringement of the Trademarks.

2. Recordation. Assignors authorize the filing of this Assignment with any office, administrative body or other official throughout the world whose duty it is to register and record ownership in trademark registrations and applications for registration, to record Assignee as the assignee and owner of any and all of Assignors’ rights in the Trademarks assigned to Assignee.

3. No Alteration. Each of the Assignors and the Assignee hereby acknowledges and agrees that none of the rights or remedies of any party under the Bill of Sale will be deemed to be enlarged, modified or altered in any way by the execution and acceptance of this instrument.

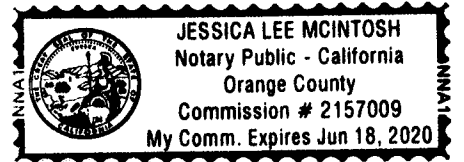

This Assignment may be executed in one or more counterparts, each of which will be deemed an original and binding as of the date first written above, and, when delivered, all of which will constitute one and the same instrument.
