FOURTH: The amount of the total stock of this corporation is authorized to issue is 10,000 shares (number of authorized shares) with no par value.

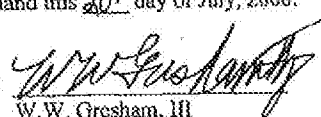
