## NOTICE OF SECURITY INTEREST IN TRADEMARKS

A. B. In connection with the Credit Agreement, the Company, the Agent, and the other parties thereto, have executed an Amended and Restated Guaranty and Security Agreement dated concurrently herewith (as it may be amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement");

C. The Company has adopted, used and is using its trademark listed on Exhibit A attached hereto (the "Trademark"), which Trademark is registered with or application therefore is pending before, the United States Patent and Trademark Office; and


