**RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST**

**THIS RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST** (this “**Release**”), dated as of January 31, 2018 (the “**Effective Date**”), is made by **HEALTHCARE FINANCIAL SOLUTIONS, LLC**, acting as the successor administrative agent (in such capacity, the “**Successor Agent**”) to **GE CAPITAL CANADA FINANCE INC.** (the “**Old Agent**”).

**WHEREAS**, Canadian Hospital Specialties Limited (as successor by amalgamation to Canadian Hospital Specialties ULC, Benlan Inc., and Inter V Medical Inc., respectively) (the “**Grantor**”) are parties to one or more intellectual property security agreements identified in Exhibit A attached hereto (the “**Agreements**”) pursuant to the Grantor granted a security interest in and to the intellectual property rights owned by the Grantor (the “**Security Interest**”), including the patents, patent applications, and trademark registrations listed in Exhibit “B” attached hereto (the “**IP Collateral**”);

**WHEREAS**, pursuant to the Assignment of Intellectual Property Security Agreements dated February 2, 2016, executed by the Old Agent and the Successor Agent, the Old Agent has assigned to Successor Agent all of its rights, title, and interests in and to the Agreements;

**AND WHEREAS** Successor Agent confirms that it has not assigned or otherwise disposed of its Security Interest in and to any of the IP Collateral; and

**AND WHEREAS** Successor Agent now desires to confirm the termination and release of the Security Interest in and to the IP Collateral.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Successor Agent hereby unconditionally and expressly releases, terminates, and extinguishes and has unconditionally and expressly released, terminated and extinguished any and all of its right, title, and interest in and to any and all liens and security interests, including the Security Interest, it may have upon the IP Collateral and made part hereof, which liens and security interests were established under and pursuant to the Agreements;

**AND** the Successor Agent hereby directs Canadian Intellectual Property Office, the United States Patent and Trademark Office, and any other corresponding governmental authority to record this Release in such places as deemed necessary or advisable to give effect hereto;

**AND** the Successor Agent shall, at the request and cost of the Grantor, take all further actions, and provide to the Grantor, their respective successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor to more fully and effectively release, terminate and extinguish any such liens and security interests, including the Security Interest, upon the IP Collateral;

**AND** this Release shall be binding upon the Successor Agent’s legal representatives, assigns and successors.
