RELEASE OF TRADEMARK SECURITY AGREEMENTS

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT (the “Release”) is made on this 31st day of January, 2018 by Bank of America, N.A., in its capacity as administrative agent for a group of lenders (in such capacity, the “Administrative Agent”).

WHEREAS, pursuant to (i) that certain Third Amended and Restated Security Agreement dated as of January 31, 2014, among Genesco Brands, LLC, a Delaware limited liability company (“Genesco Brands”), and Hat World, Inc., a Minnesota corporation (“Hat World” and together with Genesco Brands, the “Grantors”), certain of its affiliates and Administrative Agent (the “Security Agreement”), and (ii) (a) that certain Second Amended and Restated Trademark Security Agreement dated January 31, 2014, by and between Genesco Brands and the Administrative Agent, which amended and restated that certain Trademark Security Agreement dated January 21, 2011, (b) that certain Second Amended and Restated Trademark Security Agreement dated January 31, 2014, by and between Hat World and the Administrative Agent, which amended and restated that certain Trademark Security Agreement dated January 21, 2011 (collectively, the “Trademark Security Agreements”), the Grantors pledged and granted the Administrative agent a lien on and security interest in and to all of its right, title and in interest in those certain Trademarks identified on Exhibit A attached hereto and together with all Trademark Collateral (the “Released Collateral”). Capitalized terms used herein but not otherwise defined shall have the meaning given such terms in Trademark Security Agreements.

WHEREAS the security interest granted to the Administrative Agent was recorded at the (i) United States Patent and Trademark Office on February 6, 2014 at Reel 5210 on Frame 0041; on February 6, 2014 at Reel 5210 and Frame 0020; April 1, 2011 at Reel 004512 and Frame 0051; January 27, 2011 at Reel 004461 and Frame 0818, and Reel 004461 and Frame 0587; and (ii) the Canadian Intellectual Property Office on March 9, 2011 as File No. 1250070, 174881 and 795486.

WHEREAS, the Administrative Agent has agreed to terminate and release all of its interest in and to the Released Collateral; and

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Administrative Agent hereby irrevocably terminates, releases and discharges all mortgages, liens, security interests and any other rights that are or may have been granted to the Administrative Agent in and to the Released Collateral.

THIS RELEASE SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.






