TRADEMARK ASSIGNMENT

1. Assignor hereby assigns to Assignee all of their interests in and to the Trademark Registrations and all of the business plans and intentions developed, prepared, planned, and put in place, and all of the goodwill associated with, and identified in, the Trademark Registrations.
2. In conjunction with the transfer of Assignor’s interests in the Trademark Registrations to Assignee, Assignors hereby assigns, transfers, and otherwise conveys to Assignee all right, title, and interest in and to all claims, demands and causes of action against a third party for the past infringement of the marks identified in the Trademark Registrations, including the right to collect damages for past infringement.
3. Assignor further covenants that it will take all actions that may be necessary for securing, completing, or vesting in the Assignee full right, title, and interest in the Trademark Registrations.
