RELEASE OF SECURITY INTEREST IN UNITED STATES TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN UNITED STATES TRADEMARKS** (this "Release"), dated as of February 6, 2018, is made by Golub Capital Markets LLC (f/k/a GCI Capital Markets LLC), as collateral agent (the "Collateral Agent"), in favor of Capital Vision Services, LP (the "Grantor"). Capitalized terms used but not otherwise defined herein shall have the respective meanings given thereto in the Security Agreement (as defined below).

WHEREAS, the Grantor and the Collateral Agent are parties to that certain (1) Pledge and Security Agreement, dated as of August 14, 2015 (as amended, modified, restated and/or supplemented from time to time, the "Security Agreement"), and (2) Grant of Security Interest in United States Trademarks, dated as of August 14, 2015 (the "Grant"), pursuant to which the Grantor granted to the Collateral Agent a continuing security interest in, to and under (i) the Trademarks (as defined in the Grant), including the registrations and applications for registration set forth in Schedule A attached hereto, (ii) all Proceeds and products of the Trademarks, (iii) the goodwill of the businesses with which the Trademarks are associated, and (iv) all causes of action arising prior to or after the date of the Grant for infringement of any of the Trademarks or unfair competition regarding the same (collectively, the "Trademark Collateral");

WHEREAS, the Grant was recorded with the U.S. Patent and Trademark Office on August 19, 2015 at Reel/Frame 5602/0616; and

WHEREAS, the Collateral Agent has agreed to execute and deliver this Release to evidence the release of its security interest in, to and under the Trademark Collateral.

NOW THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent, without any representation, warranty or recourse of any kind, hereby terminates, releases and discharges its security interest in the Trademark Collateral, and hereby re-assigns, re-transfers and re-conveys to Grantor any and all right, title and interest the Collateral Agent may have in, to or under the Trademark Collateral.


