RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release granted on this 30th day of August, 2013, by **RBS CITIZENS, NATIONAL ASSOCIATION**, a national association (the "**Grantor**") to **MRP ACQUISITION LLC**, a Delaware limited liability company (the "**Grantee**"), as follows:

WHEREAS, the Grantee has heretofore granted to the Grantor a security interest in certain trademark registrations and applications (the "Marks") set forth on Schedule A attached hereto, and defined by the Amended and Restated Term Loan Credit Agreement dated December 22, 2005 (as amended, modified, restated and/or supplemented from time to time, the "Credit Agreement"); and granted in conjunction with the security interest granted to the Grantor under that certain Conditional Assignment of Trademarks and Notice of Grant of Security Interest in Trademarks dated as of December 15, 1998 (as amended and in effect, the "Security Agreement");

WHEREAS, the Grantor wishes to provide a document suitable for recording in the United States Patent and Trademark office for purposes of recording and restoring all right, title and interest in and to the Marks and the goodwill associated with the business represented by the Marks to the Grantee, and further acknowledges payment in full of all the Obligations of the Grantee, as such term is defined in the Credit Agreement, against which the security interest in the Marks served as collateral.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Grantor hereby releases, discharges, reconveys, and relinquishes unto the Grantee any and all right, title and interest in and to the Marks and the goodwill associated with the business represented by the Marks, as defined by the Security Agreement, which was duly recorded with respect to the Trademarks identified in Schedule A in the United States Patent and Trademark Office on May 21, 2008 at Reel 003781, Frame 0249.
