

Assignor agrees that it will communicate to said Assignee or its representatives any facts known to Assignor respecting said trademarks.

FURTHER, Assignor represents, warrants and agrees that upon the reasonable request of Assignee and at Assignee's expense, Assignor shall execute and deliver any further instruments or documents and take all such further action, or cause any affiliate of Assignor to do the same, to perfect Assignee's right, title and interest in said Marks assigned by this Agreement.


