**RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this “**Release**”), dated as of February 7, 2018, is made by **LEVINE LEICHTMAN CAPITAL PARTNERS SBIC FUND, L.P.**, as Agent (the “**Agent**”), under the Note Purchase Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Note Purchase Agreement).

**WHEREAS**, in connection with that certain Note Purchase Agreement (the “**Note Purchase Agreement**”), dated as of December 12, 2014, by and among Lawn Doctor, Inc., a New Jersey corporation (“**Lawn Doctor**”), each other Person that from time to time becomes a borrower thereunder pursuant to the terms thereof (together with Lawn Doctor, each a “**Company**” and collectively, the “**Companies**”), Lawn Doctor, as Company Representative, the financial institutions party thereto from time to time, as Purchasers, and Agent, and together with all general security agreements, trademark security agreements and copyright security agreements entered into in connection therewith or in connection with prior versions thereof, the Purchasers extended credit to the Companies;

**WHEREAS**, in connection with the Note Purchase Agreement, and pursuant to those certain trademark security agreements and copyright security agreement described on Annex I attached hereto (collectively, and as each is amended, restated, supplemented or otherwise modified prior to the date hereof, the “**Security Agreements**”), the Companies granted a lien on and security interest in the intellectual property owned by such Company, including those items listed on Annex I attached hereto (collectively, the “**Intellectual Property Collateral**”); and

**WHEREAS**, the Security Agreements were recorded in the U.S. Patent and Trademark Office and in the U.S. Copyright Office, respectively, on the dates and on the reels and frames set forth on Annex I hereto.

**NOW THEREFORE**, in consideration of the material covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent, on behalf of itself and each other Purchaser, hereby **RELEASES**, terminates and discharges, without representation, recourse or warranty whatsoever, all of its rights, title and interest in, to and under, including its lien on and security interest in, and right of setoff against, the Intellectual Property Collateral, including the intellectual property registrations and applications set forth on Annex I attached hereto, together with any goodwill related thereto, granted pursuant to the Security Agreements or any other agreement or document delivered in connection with the Note Purchase Agreement, and the Agent hereby reassigns to such Company any and all such right, title and interest (if any) that the Agent may have in, to and under the Intellectual Property Collateral granted pursuant to the Security Agreements or any other agreement or document delivered in connection with the Note Purchase Agreement.

The Agent agrees, at the Companies’ expense, to cooperate with the Companies and to provide the Companies with the information and additional authorization reasonably required or

desirable to effect the release of the Agent's security interest in the released collateral described herein.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.





