**ASSIGNMENT OF TRADEMARK APPLICATIONS,
REGISTRATIONS AND DOMAIN NAMES**

This ASSIGNMENT OF TRADEMARK APPLICATIONS, REGISTRATIONS AND DOMAIN NAMES (this "Assignment") is made and executed as of January 16, 2018 (the "Effective Date"), by and between Dick's Sporting Goods, Inc., a Delaware corporation having a place of business at 345 Court Street, Coraopolis, Pennsylvania 15108 ("Assignor") and Ram Golf Ltd, a Hong Kong limited company having a place of business at Suite 14A, Capri Building, 130 Austin Road, Kowloon, Hong Kong ("Assignee"). All capitalized terms used herein and not defined herein shall have the respective meanings ascribed to such terms in that certain Asset Purchase Agreement dated as of January 16, 2018, by and between Assignor and Assignee (the "Agreement").

WHEREAS, pursuant to the Agreement, Assignor has agreed to assign to the Assignee all of the Assignor's rights, title and interests in and to the DKS IP identified on Schedule A.

WHEREAS, in order to effectuate Assignor's assignment of its entire rights, title and interests in and to the DKS IP and the goodwill appurtenant thereto, to Assignee, Assignor is executing this instrument of Assignment.

NOW, THEREFORE, in consideration of the Agreement, the sum of US \$100.00 (one hundred US dollars), and other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged by the Assignor, Assignor does hereby sell, assign, convey and transfer unto Assignee, its successors, assigns and legal representatives, its full and entire rights, title and interests in and to the Marks and Domains identified in said Schedule A, and the attendant goodwill symbolized by the foregoing, the same to vest in Assignee, including, without limitation, the ownership of all causes of action for, and claims for damages by reason of, the infringement of any of the Marks by other parties, which causes of action and claims arose prior to the date of execution hereof.

ASSIGNEE AGREES THAT TRADEMARK APPLICATIONS, REGISTRATIONS AND DOMAINS ARE ASSIGNED TO ASSIGNEE ON AN "AS IS" BASIS, AND ASSIGNOR EXPRESSLY DISCLAIMS ANY AND ALL REPRESENTATIONS AND WARRANTIES OF ANY KIND, EITHER EXPRESS OR IMPLIED, INCLUDING ANY WARRANTIES OF OWNERSHIP, TITLE, VALIDITY, ENFORCEABILITY OR NON-INFRINGEMENT.

Assignor hereby agrees that Assignee shall have the right, at its sole cost and expense, to record this instrument of assignment with the United States Patent and Trademark Office and with any other agency, office or authority in any and all other jurisdictions and countries of the world, so as to establish Assignee as owner of record of the Marks and the Domains.

Assignor further agrees, at the request of Assignee and at Assignee's sole cost and expense, to (i) execute and have executed any and all other documents of any kind whatsoever, and to provide whatever information may be required, to carry out the terms and intent of this Assignment; and (ii) fully cooperate with Assignee, as reasonably required, to enable Assignee

to duly record this instrument of assignment with the United States Patent and Trademark Office and with any other agency, office or authority in any and all other jurisdictions and countries of the world, so that Assignee's ownership of the Marks and the Domains is duly made of record.

This Assignment shall be subject to the terms, conditions and covenants set forth in the Agreement and, in the event that any provision of this Assignment is construed to conflict with a provision in the Agreement, the provision in the Agreement shall be deemed to be controlling. This Assignment shall be governed by and construed in accordance with the laws of the State of Delaware. This Assignment may be executed in one or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument. Nothing in this Assignment, expressed or implied, is intended or shall be construed to confer upon or give to any person, firm or corporation other than Assignor and Assignee, their successors and assigns, any remedy or claim under or by reason of this instrument or any term, covenant or condition hereof, and all of the terms, covenants, conditions, promises and agreements contained in this instrument shall be for the sole and exclusive benefit of Assignor and Assignee, their successors and assigns.

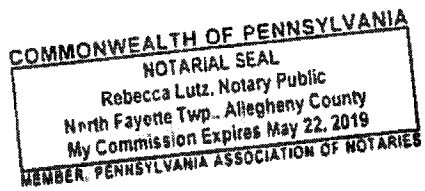
