## TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS**, dated as of February 8, 2018 (this "Termination"), is made by JEFFERIES FINANCE LLC, located at 520 Madison Avenue, New York, New York 10022, as collateral agent for the Secured Parties (in such capacity, including any successor thereto, the "Collateral Agent"), in favor of (i) Keynote Systems, Inc., a Delaware corporation and (ii) Compuware Corporation, a Delaware corporation (collectively, the "Grantors"). Except as otherwise provided herein, capitalized terms used herein but not otherwise defined have the meanings set forth (or incorporated) in the Trademark Security Agreement referenced below.

WHEREAS, pursuant to the Trademark Security Agreement, the Grantor pledged and granted a continuing security interest in, and a right or setoff against, Grantors' right, title and interest in, to and under the Trademark Collateral, which includes the Trademark registrations and applications listed on Schedule A hereto, to the Collateral Agent, for the benefit of the Secured Parties, to secure payment, performance and observance of the Secured Obligations.

WHEREAS, the Grantors entered into that certain Second Lien Trademark Security Agreement, dated as of December 15, 2014 (the "Trademark Security Agreement"), in favor of the Collateral Agent;

WHEREAS, the Trademark Security Agreement was recorded in the records of the United States Trademark and Trademark Office on March 13, 2015 at (i) Reel 5477 and Frame 0302 and (ii) Reel 5477 and Frame 0324;

WHEREAS, the Collateral Agent acknowledges the Secured Obligations have been repaid; and

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all of the Trademark Collateral, including, without limitation, the trademark registrations and applications identified on Schedule A attached hereto.

NOW, THEREFORE, in consideration of the provisions set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Release of Lien. The Collateral Agent hereby terminates the Trademark Security Agreement and hereby terminates, cancels and releases any and all security interests that it has in, to and under all Trademark Collateral.

2. Authorization to Record. The Collateral Agent authorizes and requests that the United States Trademark and Trademark Office and any applicable government officer record this Termination.

3. Further Assurances. The Collateral Agent shall take all further actions and provide to the Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of documents or other instruments), reasonably requested by the Grantor to more fully and effectively effectuate the

purposes of this Termination, at the Grantors' sole expense, and without representation or warranty by the Collateral Agent.

4. Governing Law. This Termination shall be construed in accordance with and governed by the laws of the state of New York, without regard to conflict of laws principles.
