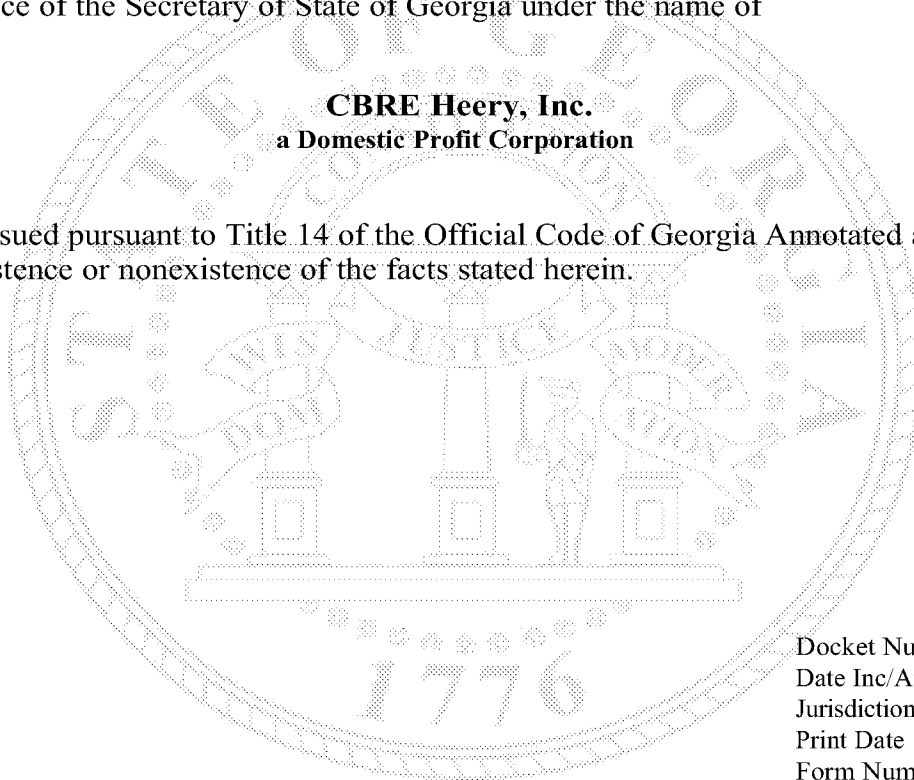

Pursuant to Section 14-2-1006 of the Georgia Business Corporation Code ("BCC"), HEERY INTERNATIONAL, INC., a Georgia corporation, hereby submits the following Articles of Amendment:

1.

The name of the corporation is HEERY INTERNATIONAL, INC. (the "Corporation").

This amendment adopted by the Corporation (the "Amendment") amends a provision of the Corporation's Amended and Restated Articles of Incorporation filed with the Secretary of State on February 18, 1986, as amended on July 19, 1991 (the "Articles of Incorporation").
