**Third:** The name of the surviving limited liability company is: FOUNDATION BUILDING MATERIALS, LLC.

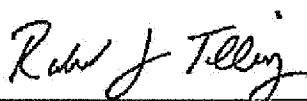
**Fourth:** The effective date of this merger shall be December 29, 2017.
