**TERMINATION AND RELEASE OF SECURITY INTEREST IN
INTELLECTUAL PROPERTY**

This **TERMINATION AND RELEASE OF SECURITY INTERESTS IN INTELLECTUAL PROPERTY** (this "*Termination and Release*") is granted as of January 8, 2018, by VENTURE LENDING & LEASING VI, INC. ("*VLL6*") and VENTURE LENDING & LEASING VII, INC. ("*VLL7*", and together with *VLL6*, the "*Grantees*"), in favor of BOUNTYJOBS, INC., a Delaware corporation (the "*Grantor*").

WHEREAS, Grantor executed and delivered that certain Intellectual Property Security Agreement dated as of May 29, 2014 (as amended, modified or supplemented prior to the date hereof, the "*Agreement*"), granting each of the Grantees a security interest in and lien on certain Collateral, as such term is defined therein;

WHEREAS, capitalized terms used but not defined herein shall have the meanings set forth in the Agreement.

WHEREAS, the Agreement was recorded in the Assignment Division of the United States Patent and Trademark Office ("*USPTO*") on May 30, 2014, at Reel 033062, Frame 0514 and Reel 5291, Frame 0401;

WHEREAS, the Grantor has requested that the Grantees hereby terminate, release and discharge fully their respective security interests in and liens on all right, title and interest of the Grantor in, to and under all of the Collateral described in the Agreement as herein provided; and

WHEREAS, the Grantor has requested that the Grantees provide a document suitable for recording with the USPTO to evidence the release of their respective security interests in and liens on the Collateral as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each of the Grantees hereby:

1. terminates the Agreement and irrevocably releases, terminates and discharges all liens and security interests in each of Grantor's right, title and interest in, to and under the Collateral, and all goodwill associated therewith, including without limitation the Collateral identified in Exhibit A, Exhibit B and Exhibit C hereto;
2. authorizes and requests that this Termination and Release be recorded at the USPTO; and
3. agrees that it shall, and at any of Grantor's, or its respective successor's or assign's, reasonable request, execute, acknowledge and deliver to such Grantor all further releases and other documents, and take all other actions necessary or reasonably desirable for the release of such security interest.

THIS TERMINATION AND RELEASE AND ANY CLAIM, CONTROVERSY, DISPUTE OR CAUSE OF ACTION (WHETHER IN CONTRACT OR TORT OR OTHERWISE) BASED

UPON, ARISING OUT OF OR RELATING TO THIS TERMINATION AND RELEASE AND THE TRANSACTIONS CONTEMPLATED HEREBY AND THEREBY SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE UNITED STATES AND THE STATE OF CALIFORNIA, WITHOUT GIVING EFFECT TO ANY CHOICE OR CONFLICT OF LAW PROVISION.
