Assignor agrees that on request it shall, at any time and without charge to Assignee, sign all papers, take all rightful oaths, execute any and all documents, and do all acts which may be necessary or desirable to vest title to or possession and control of the Marks in Assignee or in its successors, assigns and legal representatives or nominees.
3. Successors and Assigns. This Assignment shall bind and inure to the benefit of the parties and their respective successors and assigns.
