**RESTATED ARTICLES OF INCORPORATION**  
**OF**  
**SUPERIOR PLUS CONSTRUCTION PRODUCTS CORP.**

ARTICLE I.  
NAME AND TERM

The name of the Corporation shall be FBM GALAXY, INC. The term of the Corporation's existence shall be perpetual.

ARTICLE II.  
STATUTORY AUTHORITY

The Corporation is incorporated under the Pennsylvania Business Corporation Law of 1988, as amended ("PBCL").

ARTICLE III.  
REGISTERED OFFICE

The address of the Corporation's registered office in the Commonwealth of Pennsylvania is: National Corporate Research, Ltd., Dauphin County.

ARTICLE IV.  
CAPITAL STOCK

The aggregate number of shares that the Corporation shall have authority to issue one hundred (100) shares of Common Stock, \$0.01 par value per share.

ARTICLE V.  
NO CUMULATIVE VOTING RIGHTS

The shareholders of the Corporation shall not have the right to cumulate their votes for the election of directors of the Corporation.

ARTICLE VI.  
DIRECTORS

A director of the Corporation shall not be personally liable, as such, for monetary damages for any action taken, or any failure to take any action; provided, however, that this provision shall not eliminate or limit the liability of a director to the extent that such elimination or limitation of liability is expressly prohibited by Section 1713 of the PBCL, or any successor statute as in effect at the time of the alleged action or failure to take action by such director. Any repeal or modification of this Article VI by the shareholders of the Corporation shall not adversely affect any right or protection existing at the time of such repeal or modification to which any person may be entitled under this Article VI.
