## RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this “Release”), dated effective as of February 15, 2018, is made by **Bank of America, N.A.**, as Administrative Agent (the “Administrative Agent”), with respect to the security interest granted to it by **Target Logistics Management, LLC** (the “Grantor”), in the IP Collateral (defined below). Capitalized terms used in this Release but not defined herein shall have the respective meanings ascribed to such terms in the Security Agreement (defined below).

### WITNESSETH

WHEREAS, reference is made to that certain Security and Pledge Agreement dated as of October 11, 2012 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”) among the Administrative Agent, the Grantor and certain other Persons;

WHEREAS, pursuant to the Security Agreement, Grantor entered into that certain Intellectual Property Security Agreement (the “IP Security Agreement”), dated as of January 17, 2014, in favor of Administrative Agent for the Secured Parties (as defined in the Credit Agreement referred to below).

WHEREAS, the IP Security Agreement was recorded in the U.S. Patent and Trademark Office on March 4, 2014 on Reel/Frame 5230/0110;

WHEREAS, Grantor, Administrative Agent and the other parties party thereto entered into that certain Amended and Restated Syndicated Facility Agreement, dated as of December 19, 2013 (as supplemented by that certain U.S. Revolver Increase Supplement, dated as of December 19, 2013, as amended by that certain Amendment No. 1 to Amended and Restated Syndicated Facility Agreement, dated as of March 24, 2014 and by Amendment No. 2 to Amended and Restated Syndicated Facility Agreement, dated as of March 31, 2017, as amended by Amendment No. 3 as of the Third Amendment Effective Date (as defined therein), and as further amended, restated, amended and restated, supplemented or otherwise modified prior to the date hereof, the “Credit Agreement”); and

WHEREAS, Administrative Agent has agreed to release its security interest under the IP Security Agreement in the IP Collateral (as defined below) as set forth herein.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Administrative Agent hereby agrees as follows:

**1. Definitions:** “IP Collateral” means the Collateral (as defined in the IP Security Agreement) owned by Grantor, including the trademark registrations and trademark applications identified in Schedule A hereto.

**2. Release of Security Interest:** The Administrative Agent hereby releases and discharges fully, without representation, warranty or recourse, its security interest under the IP Security

Agreement in and to all of the Grantor's right, title and interest in and to the IP Collateral (the "Released Collateral").


**3. Recordation:** Administrative Agent authorizes the recordation of this Release with the U.S. Patent and Trademark Office to place on record the release of the security interest in the Released Collateral by Administrative Agent.

**4. Governing Law.** THIS RELEASE SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.
