**ASSIGNMENT OF SHORT FORM INTELLECTUAL PROPERTY
SECURITY AGREEMENT**

This **ASSIGNMENT OF SHORT FORM INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this “**Assignment**”), dated as of February 14, 2018, is by and between **KEYBANK NATIONAL ASSOCIATION** (individually, “**KeyBank**”), acting in its capacity as the current and resigning administrative agent (in such capacity, the “**Retiring Agent**”) and **U.S. BANK NATIONAL ASSOCIATION** (individually, “**U.S. Bank**”), acting in its capacity as the successor administrative agent (in such capacity, the “**Successor Agent**”).

RECITALS:

WHEREAS, Select Comfort Retail Corporation, a Minnesota corporation (successor by merger to SleepIQ LABS Inc., a Delaware corporation), and Retiring Agent are parties to those certain short form intellectual property security agreements identified in Exhibit A attached hereto (as the same may have been amended, restated, supplemented or otherwise modified from time to time, collectively, the “**Agreements**”) covering certain intellectual property, including those set forth on Exhibit B attached hereto; and

WHEREAS, pursuant to that certain Amended and Restated Credit Agreement by and among, Sleep Number Corporation, U.S. Bank, as Successor Agent and the lenders party thereto (x) Retiring Agent has been discharged from its rights, duties and obligations under, among other documents, the Agreements, in each instance, in its capacity as administrative agent and (y) Successor Agent has assumed such rights, duties and obligations under, among other documents, the Agreements, in each instance, in the capacity as administrative agent.

NOW, THEREFORE, in consideration of the foregoing, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Retiring Agent hereby assigns and transfers to Successor Agent and its successors and assigns, all of its rights, title and interest in and to the Agreements.

This Assignment may be executed in any number of counterparts, each of which when so executed shall be deemed an original and all of which taken together shall constitute one and the same instrument.


