COLLATERAL ASSIGNMENT OF TRADEMARKS AND SECURITY INTERESTS**


THIS RELEASE OF COLLATERAL ASSIGNMENT OF TRADEMARKS AND SECURITY INTERESTS (“**Release**”) is dated as of February 15, 2018 (the “**Effective Date**”).
