RELEASE OF TRADEMARK COLLATERAL

THIS RELEASE OF TRADEMARK COLLATERAL (this "Release") is made as of February 12, 2018 by WELLS FARGO BANK, NATIONAL ASSOCIATION, in its capacity as collateral agent pursuant to the Indenture referred to in the Second Lien Security Agreement (as defined below) (in such capacity, the "Collateral Agent").

WITNESSETH:

WHEREAS, RSI HOME PRODUCTS MANAGEMENT, INC., a Delaware corporation (the "Grantor"), having an address at 400 East Orangethorpe Avenue, Anaheim, CA 92801, and certain other entities executed that certain Second Lien Security Agreement, dated as of March 16, 2015 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"; capitalized terms used in this Release without definition having the meanings provided in the Security Agreement), in favor of the Collateral Agent, pursuant to which the Grantor granted a security interest to the Collateral Agent in certain trademarks and other intellectual property of Grantor; and

WHEREAS, in connection with said Security Agreement and a trademark security agreement executed pursuant thereto, documentation was recorded with the United States Patent and Trademark Office at Reel 5480, Frame 0268 on March 16, 2015.

WHEREAS, pursuant to a written request from the Grantor and in connection with the satisfaction and discharge of the Indenture, pursuant to the Indenture and the Security Agreement, the Collateral Agent agreed to deliver to the Grantor an instrument acknowledging the termination of the Security Agreement and the release of all liens on all of the trademarks and trademark applications of the Grantor, including, without limitation, those identified on Exhibit A attached hereto and made a part hereof, all goodwill associated with such trademarks and trademark applications and all proceeds of any of the foregoing (the "Released Collateral"), and to reconvey any and all rights in the Released Collateral to the persons legally entitled thereto.

WHEREAS, on the date hereof, the Collateral Agent has received an Officer's Certificate and an Opinion of Counsel each stating that all conditions precedent under the Indenture to the execution of this Release by the Collateral Agent have been complied with.

NOW, THEREFORE, in consideration of the promises and other good and valuable consideration, receipt of which is hereby acknowledged, the Collateral Agent hereby releases all its rights in and to and lien on and continuing security interest in the Released Collateral, reconveys to the persons legally entitled thereto all of the Collateral Agent's right, title and interest in and to the Released Collateral, all without warranty or representation of any kind.
