WEB PROPERTY PURCHASE AGREEMENT

This Web Property Purchase Agreement (the “Agreement”) is entered into as of July 15, 2016, (the “Effective Date”) by and between The Modern Judaica Company, LLC, a Georgia Limited Liability Company with offices located at 1351 Hooper Avenue NE, Atlanta, GA 30307 (the “Seller”), and Jennifer Rivlin an individual, with respect to her obligations hereunder, and WHAT JEW WANNA EAT, LLC, a Texas Limited Liability Company with offices located at 1602 Fair Oaks Dr., Austin, TX 78745-2808 (the “Buyer”).

WHEREAS, Seller owns good, valid and marketable title to the Web Property (as defined in Section 1 below); and

WHEREAS, Buyer wishes to purchase the Web Property upon the terms and conditions set forth herein;

NOW, THEREFORE, in consideration of the mutual covenants and promises expressly set forth below, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledge, the parties agree as follows:

DEFINITIONS.

“Domain Names” means the domain names Popjudaica.com and Chosencouture.com and ModernTribe.com.

“Website” means any web development, articles and other website content, design work, artwork, graphics, website code, audio and video files, content management systems, databases, and other digital files related to any website located at the Domain Names.

“Customer Information” means any customer databases, e-mail addresses and any other lists of customers or potential customers or subscribers, historical records of customers, and any other customer information related to the Web Property.

“Business Records” means all relevant business strategies, technology plans, business plans, marketing strategies and plans, past or present marketing collateral and website banners and templates and marketing posters and the like, as well as business records related to the Web Property, including but not limited to all necessary financial records and documents.

“Intellectual Property” means all intellectual property, including trademarks, copyrights, and goodwill appurtenant to the Web Property,

“Social Media” means all Facebook, Twitter, and other social media accounts that are affiliated with, associated with, or related to the Web Property that are within Seller’s ownership, possession, custody, or control as of the Effective Date.

- a. “**Inventory**” means all goods and merchandise related to the Web Property that are within Seller’s ownership, possession, custody, or control as of the Effective Date, including but not limited to that shown in Exhibit A.

“Web Property” means: (1) the Domain Names (2) the Website, (3) the Customer Information, (4) the Business Records, (5) the Intellectual Property, (6) the Social Media, and (7) the Inventory. For the avoidance of doubt it is understood that no intellectual property related to No Limit Texas Dreidel and other ModernTribe custom products specifically listed in Exhibit C (Design Exhibits No), and no real property, is included within the definition of Web property.

PURCHASE PRICE; PAYMENT TERMS. In consideration for all right, title and interest related to the Web Property, and all other rights and privileges granted and agreed to be granted in this Agreement, and for all of Seller’s covenants, representations, warranties, and agreements in this Agreement, Buyer agrees to pay Seller, and Seller agrees to accept, the sum of (One Hundred and Nineteen Thousand) (\$119,000) (the “Purchase Price”).

ESCROW. The sale of the Web Property from Seller to Buyer will be transacted through an escrow account (the “Escrow Account”) managed by an “Escrow Holder.” [Escrow.com] The Parties mutually agree that escrow will proceed as follows:

Buyer will deposit the Purchase Price in the Escrow Account.

Upon receipt and clearance of Buyer’s payment, Escrow Holder will notify Seller to transfer and assign the Web Property. Seller agrees that, upon receipt of said notice from Escrow Holder, Seller will transfer the domain(s) as well as all right, title, and interest to the remainder of the Web Property to the Buyer. Buyer agrees to notify the Escrow Holder of its receipt of the Web Property, including ownership of the Domain Names.

Escrow will close upon receipt and clearance of the full Purchase Price. Upon closing, Escrow Holder will remit to Seller the Purchase Price, less any fees and expenses related to this Agreement at the time of closing except for those fees and expenses explicitly set forth herein as payable by Buyer.

SELLER'S REPRESENTATIONS AND WARRANTIES. Seller represents and warrants that: (1) Seller owns good, valid and marketable title to the Web Property; (2) the Web Property is held in Seller's name; (3) all approvals required for Seller to enter into this Agreement and to sell and transfer the Web Property (including all third-party licenses appurtenant thereto) have been duly obtained; (4) Seller has full power, authority, and ownership to enter into this Agreement and to effectuate all of the transactions contemplated, without any conflict, restrictions or limitations, imposed by any law, legal requirement, agreement, or otherwise; (5) the transfer to Buyer of Seller's right, title, and interest in and to the Web Property (including all third-party licenses appurtenant thereto) shall be free and clear of liens, claims, or encumbrances; (6) the Web Property does not infringe the intellectual property rights of any third party; (7) there are no lawsuits, threats of litigation, claims, or other demands affecting or involving the Web Property, arising or accruing before the Effective Date, which may become a liability or obligation to Buyer or adversely affect Buyer's conduct of the business involving the Web Property; (8) there are no unresolved notices of copyright or trademark infringement received by the Seller or the Seller's Internet Service Provider prior to the Effective Date relating to the Web Property, to include any Digital Millennium Copyright Act "Take Down" notices, (9) neither Seller nor any of the undersigned on behalf of seller shall start a business identical or similar to that related to the web property for a period of 2 years following the Effective Date of this Agreement.

BUYER'S REPRESENTATIONS AND WARRANTIES. Buyer represents and warrants that it enters into this Agreement after having had a full and fair opportunity, at its sole discretion, to carry out a due diligence review of the Web Property.

PAYMENT TO SELLER; TAXES, FEES, AND EXPENSES.

Advisory Expenses. Seller and Buyer agree that they will each bear their own costs and expenses for legal advice and other consultation services incurred with respect to the sale, including those of any third party.

Domain Name Transfer Fees. Seller agrees to pay all nominal fees, charges, and costs to domain name registrars incurred in connection with the sale and transfer of the Web Property, including, without limitation, Domain Name transfer or registration fees.

Taxes. Seller agrees to pay all federal, state, local, or foreign taxes incurred in connection with the sale of the Web Property.

INDEMNIFICATION. Each Party (the "Indemnitor") shall indemnify, defend and hold harmless the other part (the "Indemnitee") and its parent and respective subsidiaries and their

respective officers, directors, shareholders, affiliates, employees, agents, successors and assigns, or assignees or transferees of the Web Property, at the Indemnitor's expense, from and against any and all liability, demands, claims, costs, losses, damages, recoveries, settlements, and expenses (including interest, penalties, attorney fees, accounting fees, and expert witness fees) incurred by the Indemnitee, known or unknown, contingent or otherwise, directly or indirectly arising from or related to: (1) Indemnitor's breach of any warranties, representations, covenants or obligations contained in this Agreement; and/or (2) Indemnitor's violation of any applicable federal, state or local law.

CONFIDENTIALITY. Neither party shall disclose the terms of this Agreement, except as required by applicable law or if compelled by a court of competent jurisdiction. Notwithstanding the foregoing, this provision shall not apply to disclosures made by either party to their agents, employees and advisers to whom such disclosure is necessary in order to perform pursuant to this Agreement.

ATTORNEY'S FEES AND COSTS. If either party prevails in any action, suit, or proceeding arising from or based upon this Agreement, that party shall be entitled to recover from the other party the prevailing party's reasonable attorneys' fees in connection therewith, in addition to the costs of such action, suit, or proceeding.

DISCLOSURE OF RELEVANT INFORMATION. Seller understands and agrees that if Seller knows, or should know, of any information materially affecting the value of the Web Property, whether said information is readily discernible or publically available, that Seller has disclosed, or shall disclose, this information to Buyer.

NOTICES. Unless otherwise provided, any notice required or permitted to be delivered pursuant to this Agreement must be delivered by hand to the recipient, by email with confirmation of reading by the recipient, certified U.S. Mail with return receipt signed by the recipient, or addressed to the recipient as set forth below the signature line of the party to whom notice is being given, or to such other address as the parties may from time to time designate by notice in writing to the other party.

GOVERNING LAW; JURISDICTION & VENUE.

This Agreement, including without limitation this Agreement's interpretation, shall be treated as though this Agreement were executed and performed in Austin, Texas, and shall be governed by and construed in accordance with the laws of the State of Texas without regard to its conflict of law principles. The language in this Agreement shall be interpreted in accordance with its fair meaning and not strictly for or against either party. **THE PROPER VENUE FOR ANY JUDICIAL ACTION ARISING OUT OF, RELATING TO, OR IN CONNECTION WITH THIS AGREEMENT WILL BE THE STATE AND FEDERAL COURTS LOCATED IN OR NEAREST TO AUSTIN, TX. THE PARTIES HEREBY STIPULATE TO, AND AGREE TO WAIVE ANY OBJECTION TO, THE PERSONAL JURISDICTION AND VENUE OF SUCH COURTS, AND FURTHER EXPRESSLY SUBMIT TO EXTRATERRITORIAL SERVICE OF PROCESS.** Notwithstanding the foregoing, any controversy or claim arising out of or relating to this contract, or the breach thereof, shall be settled by arbitration administered by the American Arbitration Association under its Commercial Arbitration Rules. The number of arbitrators shall be one. The place of arbitration shall be Austin, Texas. Judgment on the award rendered by the arbitrator(s) may be entered in any court having jurisdiction thereof.

Nothing herein will preclude either party from applying to a Court of Competent Jurisdiction for a temporary restraining order, preliminary injunction, or other interim or conservatory relief, as necessary. As used herein, "Court of Competent Jurisdiction" means any federal or state court: (1) that has jurisdiction over the subject matter; and (2) that is located in a state where Seller, Domain Names, hosting services or Buyer is located or has significant contacts.

ENTIRE AGREEMENT; SUCCESSORS; SEVERABILITY. This Agreement constitutes and represents the entire agreement between the parties and supersedes any prior understandings or agreements, written or oral, between the parties respecting the subject matter of this Agreement. This Agreement may be amended, supplemented or modified only upon an agreement in writing executed by all of the parties. This Agreement shall inure to the benefit of and shall be binding upon the parties and their respective successors and assigns. If any provision of this Agreement shall be determined to be invalid, void illegal or inoperative, such provision shall be construed and amended in a manner which would permit its enforcement and maintain the parties' original intent, but in no event shall such provision affect, impair or invalidate any other provision in this Agreement.

- 2. PROVISION OF CONSULTING SERVICES.** The undersigned Jennifer Rivlin further agrees, on behalf of herself personally, to provide Buyers with up to 100 hours of consulting services using her best efforts during the 12 months following the Effective Date of this Agreement at no additional cost, and to provide additional consulting hours during that time at a rate of \$100 per hour, as available.

EXECUTION OF ADDITIONAL DOCUMENTS. The Parties shall execute and deliver such additional documents as may be reasonably necessary to effectuate the intent and terms and purpose of this Agreement, including but not limited to any documents necessary to effect the transfer and assignment of the Web Property, including but not any documents necessary for the registration of copyrights or trademarks.



Except as provided herein, the failure to exercise a right or require performance of an obligation under this Agreement shall not affect a party's ability to exercise such right or require such performance at any time thereafter nor shall the waiver of a breach constitute waiver of any subsequent breach.

HEADINGS. The headings contained in this Agreement are inserted as a matter of convenience and for ease of reference only and shall be disregarded for all other purposes, including the construction or enforcement of this Agreement or any of its provisions.

COUNTERPARTS. This Agreement may be executed in one or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument. Photocopies, signatures reproduced by mechanical, digital or other means, and/or facsimile transmittal signature pages may be used instead of originals.
