c) all rights to sue for past, present and future infringement or misappropriations of the marks.

2. The Assignor further covenants that it will take all actions that may be necessary for securing, completing, or vesting in Assignee full right, title, and interest in the Mark and its related property.



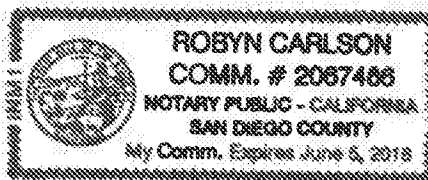
