**AMENDED AND RESTATED**  
**CONFIRMATORY TRADEMARK ASSIGNMENT AGREEMENT**

This Amended and Restated Confirmatory Trademark Assignment Agreement (the "Agreement") amends and restates in its entirety, effective as of December 31, 2017, the Confirmatory Trademark Assignment Agreement entered into between Sonovia Holdings LLC, a Delaware limited liability company (the "Assignor") and Carewear Corp., a Delaware corporation (the "Assignee"), dated January 22, 2018, effective as of December 31, 2017.

A. All of Assignor's rights in the marks listed in Schedule A attached hereto (the "Marks") were assigned to Assignee pursuant to that certain Amended and Restated Bill of Sale and Assignment between Assignor and Assignee, dated February 19, 2018, effective as of December 31, 2017.

B. This Agreement is entered into to confirm the assignment and transfer of all of Assignor's rights in the Marks (and other rights as more fully set forth below) to Assignee.

Accordingly, in consideration of the promises contained herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Assignor hereby assigns, transfers, and conveys to Assignee, the Assignor's entire right, title and interest in and to the Marks, together with the applications and/or registrations thereof and the goodwill of the business associated therewith, including all common law rights, and all claims for damages by reason of past infringement of the Marks, with the right to sue and collect therefor (collectively, the "Assigned Rights").

2. This Agreement constitutes evidence of the assignment of the Assigned Rights by Assignor to Assignee and may be presented to any relevant authority for the purpose of registration or recordation of the Assignee's right, title and interest in the Assigned Rights. Assignor will execute any and all other documents that may be needed to record, vest, or perfect Assignee's right, title, and interest in the Assigned Rights.
