**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (“Release”), effective as of this 26th day of February, 2018, is made by **SUNTRUST BANK**, a Georgia bank, with an address at 211 Perimeter Center Parkway, Suite 100, Atlanta, Georgia 30346, as administrative agent (in such capacity, together with its successors and permitted assigns, the “Administrative Agent”) for the Lenders in favor of **SITUS GROUP LLC**, a Delaware limited liability company (as successor to **THE COLLINGWOOD GROUP, LLC**, a Delaware limited liability company) (“Grantor”), as follows:

**W I T N E S S E T H**

WHEREAS, the Grantor and the Administrative Agent are party to that certain Security Agreement, dated as of March 31, 2015 (as amended, supplemented or otherwise modified from time to time, the “Security Agreement”), pursuant to which the Grantor granted to the Administrative Agent, among other Collateral as defined and set forth in the Security Agreement, a continuing security interest in various assets of Grantor, including a continuing security interest in all right, title and interest of Grantor in and to the Trademark Collateral (as defined in the Trademark Security Agreement outlined below), including all trademarks set forth on Schedule 1 attached hereto (collectively, the “Trademarks”);

WHEREAS, in furtherance of the Security Agreement, the Grantor executed a Trademark Security Agreement, dated May 16, 2017 (the “Trademark Security Agreement”), which was duly recorded on May 16, 2017, at Reel/Frame 6059/0079 in the United States Patent and Trademark Office; and

WHEREAS, the Administrative Agent wishes to release and restore all right, title and interest in and to the Trademarks to the Grantor and to dissolve those liens and encumbrances created by the Trademark Security Agreement and the Security Agreement in respect of the Trademarks.


NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Administrative Agent hereby grants, assigns, transfers and conveys, without recourse or warranty, to the Grantor all of its rights, title and interest in the Trademarks, including any goodwill associated therewith, and terminates, releases, discharges, quitclaims and relinquishes unto the Grantor any and all security interests and liens it has against the Trademarks.

The Administrative Agent hereby agrees, at Grantor’s sole cost and expense, to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the intents and purposes of this Release.
