RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS

WHEREAS, the Security Agreement was recorded with patent division of the United States Patent and Trademark Office on July 25, 2016 at Reel/Frame 039248/0715 and trademark division of the United States Patent and Trademark Office on July 25, 2016 at Reel/Frame 5842/0512.

NOW, THEREFORE, intending to be legally bound hereby, the Agent hereby releases and terminates its security interest in, and all other rights, title and interest in and to, the Patents and Trademarks, without any recourse, representation or warranty, and hereby authorizes the Grantor or Grantor's authorized representative or designee to record this Release with the United States Patent and Trademark Office as evidence of such release and termination.

This Release shall be exclusively construed in accordance with and governed by the internal laws of the Providence of Ontario and the federal laws of Canada.
