NUNC PRO TUNC TRADEMARK ASSIGNMENT

This Nunc Pro Tunc Trademark Assignment is made and entered into and shall be effective, nunc pro tunc, as of the 24th day of October, 2014 (“Effective Date”) by and between ATL Legacy, Inc., formerly known as Servidyne, Inc., a corporation organized under the laws of Georgia with a principal place of business at 1945 The Exchange SE, Suite 300, Atlanta, Georgia 30339-2040 (“Assignor”) and Flywheel Business Intelligence, Inc., formerly known as SCInergy, Inc., a corporation organized under the laws of Delaware with a principal place of business at 4101 McEwen Road, Suite 700, Dallas, Texas 75244 (“Assignee”).

WHEREAS, Assignor desires to acquire all of Assignor’s rights in and to the Trademark and Registration as set forth above;

NOW, THEREFORE, in consideration of payment of ten dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns, transfers, and conveys to Assignee all rights, title, and interest Assignor has or may have in and to the Trademark and Registration, together with the goodwill of the business symbolized by the Trademark and Registration and with the right to recover for damages and profits and all other remedies for past infringement, dilution, and unfair competition thereof as of the Effective Date. Assignor further agrees to execute and deliver to Assignee, its successors and assigns, such other and further assignments, instruments, and documents as Assignee reasonably may request from time to time for the purpose of establishing, registering, evidencing, enforcing, or defending Assignee’s ownership of all rights, title, and interest of every kind and nature whatsoever in and to the Trademark and Registration as of the Effective Date.




